WHEREAS, the name of the Corporation is River City Forum Comprehensive Care Study Club, Inc.; and

WHEREAS, the Corporation was incorporated pursuant to the provisions of the Florida Not For Profit Corporation Act, on September 12, 2012, and assigned document number N12000008771; and

WHEREAS, the undersigned Corporation, by and through its Directors and pursuant to the provisions of Section 617.1001 of the Florida Statutes, wishes to amend the aforesaid Articles of Incorporation; and

WHEREAS, the Corporation has no members, and the Board of Directors pursuant to an Action by Consent dated October 1, 2012, unanimously agreed to amend the aforesaid Articles of Incorporation in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article III - Directors of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

**"ARTICLE III
DIRECTORS**

The Board of Directors of the Corporation shall consist of not less than three (3) persons nor more than thirty-five (35) persons, the exact number to be determined in accordance with the provisions of the bylaws. The method of election of directors shall be set forth in the bylaws. The initial directors of the Corporation are:

2. A new Article XII - Officers is hereby added to read as follows:

**"ARTICLE XII
OFFICERS**

The following persons are the initial officers of the Corporation, and shall serve until their successors are elected and qualified, or until their resignation or removal pursuant to the bylaws:
