<u>ARTICLES OF INCORPORATION OF IGLESIA BAUTISTA AMISHALOM, INC</u>

A FLORIDA CORPORATION

WHEREAS, it is deemed to be desirable and in the best interests of corporation and its shareholders that it be incorporated pursuant to the Florida Non Profit Corporation Act, Chapter 617; now, therefore, be it:

RESOLVED, the undersigned, acting as incorporators of a Florida corporation under the Florida Non Profit Corporation Act, Chapter 617, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is IGLESIA BAUTISTA AMISHALOM, INC

ARTICLE II. DURATION

The corporation shall have perpetual existence. The corporate existence will commence on the filing of these articles by the Department of State

ARTICLE III. PURPOSE
