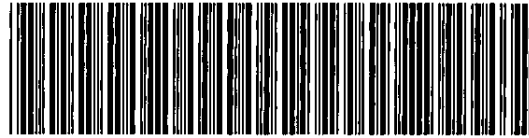

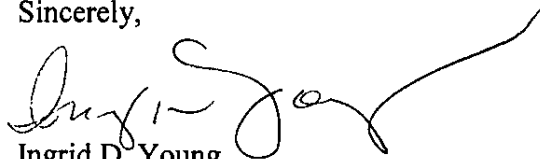

**ARTICLES OF INCORPORATION** 12 SEP 17 PM 1:29

**OF**

**BROTHERS AND SISTERS IN ARMS, INC.  
(A Non-Profit Organization)**

Pursuant to the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit, the undersigned have placed their signatures and seals upon this document for the purposes of becoming a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be: **Brothers And Sisters In Arms, Inc.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

Brothers And Sisters In Arms, Inc. is a not-for-profit and is organized and shall be operated exclusively for charitable and educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding provision of any future United States Internal Revenue law.

No part of the earnings of the Corporation shall inure to the benefit of any Director or Officer of the Corporation, or to any other person (except that the Corporation may pay reasonable compensation for services rendered to or on behalf of the Corporations and make other payment and distributions in furtherance of one or more of its purposes), and no director or Officer of Corporation, or any other person shall be entitled to share in the distribution of any of the corp assets on dissolution of the corporation. The Corporation shall pay no dividends.

The Corporation shall not participate, directly or indirectly, or intervene in (inc publishing or distribution of statements) any political campaign on behalf of or in oppos candidate for public office. The Corporation shall not have the objectives nor engag that would characterize it as an "action organization" as defined in Treasury Regulati

Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Code.

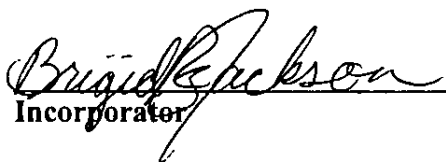

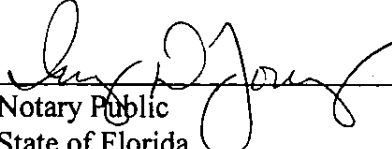
