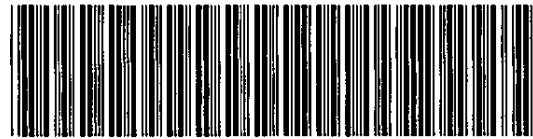

Article III - To operate exclusively for charitable, educational, and religious purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future tax code and generally to engage in any other lawful endeavor or activity in furtherance of any of the foregoing purposes.

Article IV - Election and Tenure: The initial Board of Directors shall be appointed by the incorporator and thereafter shall be elected by the Board of Directors at a regular meeting of the Board of Directors to be held at the principle office at the Islamic Center of West Tampa, Inc., or such other place as may be fixed by the Board. Directors who are elected shall serve for a term of one year, or until his or her successor is elected and qualifies, subject, however to the removal of any Director as allowed by applicable law or The Islamic Center of West Tampa bylaws.

Article IX - The provision regarding the distribution of assets upon dissolution is: Upon dissolution, after all creditors of the Islamic Center of West Tampa, Inc. have been paid, its assets shall be distributed to one or more organizations under section 501(c) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for exclusively public purposes.

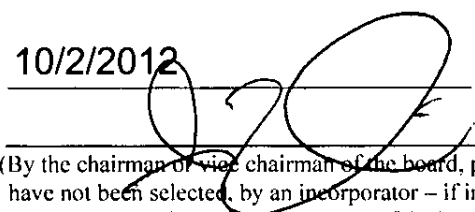
