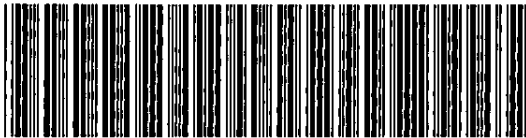





ARTICLE VIII – DISSOLUTION


