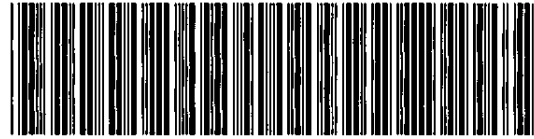

**ARTICLES OF INCORPORATION
OF MOVING FORWARD SWFL, INC.**
(A Not-for-Profit Corporation)

These Articles of Incorporation are signed and acknowledged by the incorporator for the purpose of forming a not-for-profit corporation under the provisions of Chapter 617 of the Florida Statutes known as the Florida Not for Profit Corporation Act, as follows:

ARTICLE I
NAME

The name of the corporation is: Moving Forward SWFL, Inc. (hereinafter called "Moving Forward").

ARTICLE II
DURATION

The term of this Association is fixed in perpetuity and is to commence when these Articles of Incorporation are filed with the Department of State.

ARTICLE III
PURPOSE AND POWERS

- A. By way of explanation and not of limitation, the purposes for which the Association is organized are:
1. To unite in common organization those interested in the support of survivors of lost loved ones in Lee County, Florida;
- B. The powers that the Association may exercise are any, all and every power for which a non-profit organization organized under the Florida Not for Profit Corporation Act and Florida Statutes can be authorized to exercise.

ARTICLE IV
MEMBERSHIP

The qualifications for members of the Association and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE V
REGISTERED AGENT & PRINCIPAL OFFICE

A. The initial registered agent is Scott A. Kuhn, Esq., 6720 Winkler Road, Fort Myers, FL 33919.

B. The principal office is located at 14223 Patty Berg Drive, Fort Myers, Florida 33919.

ARTICLE VI
DIRECTORS

A. The initial number of directors of the Association shall be three (3).

B. The number of directors of the Association may be increased or decreased from time to time pursuant to Bylaws but shall never be less than the minimum number of directors required by applicable law.


