



Article III shall be AMENDED as follows:

Article III

The specific purpose for which this corporation is organized is:

To provide for the needs of orphaned children and serve those who do, locally and globally. The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article VIII shall be ADDED as follows:

Article VIII

Dissolution clause:

Upon the dissolution of this organization, or in the event it shall cease to carry out the purposes stated herein, all assets remaining after the Board of Directors have paid or made provisions for payment of all of the debts and liabilities of the corporation shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

In no way shall any of the assets of this corporation or proceeds from any of the assets, in the event of dissolution, be distributed to directors, members, or donors for the reimbursement of any funds donated or contributed by such directors, members, or donors, or for any other purposes.
