THE GRACE OF GOD, THE LORD JESUS CHRIST.

Grace New Testament Church In His Blood, Inc.

ARTICLE I - CORPORATE NAME.

The name of this corporation is Grace New Testament Church In His Blood, Inc.

ARTICLE II - PURPOSE AND POWERS.

1. The purpose for which the group is formed are as follows:
 - a. That the BIBLE is the WHOLE WORD OF GOD.
 - b. We believe in preaching it and teaching it rightly divided because there is the Old Testament which is law and there is the New Testament which is grace, so then both books must be accurately, properly, rightly divided. II Timothy 2:15. New Testament.
 - c. To pray the Grace of God for the needs of all races of people, for local leaders, for national leaders and for governments, and for all that are in authority as instructed by the grace apostle Paul in I Timothy 2:1-3.
 - d. We believe under the dispensation of the law in Jesus virgin birth. St. Matthew 1:21-25.
 - e. We also believe that under the dispensation of the law he lived among the Jews of his day. St. John 1:14.
 - f. We also believe that under the dispensation of the law he was crucified on a Roman cross for our sins. St. Matthew 27:22.
 - g. We also believe that under the dispensation of the law he was raised up from the dead the third day. St. Luke 24:36-50.
 - h. To regularly assemble together the members of the body of Christ for fellowship one with another both in large public congregations and in small fellowship groups in houses and other places, to

worship God in Spirit and truth. To cooperate in the building up the whole body of Christ in his grace and finished work of the cross.

- i. To strengthen the family units with grace so that the home life of each member is healthy and fruitful by god's word rightly divided.
- j. To involve each member of his body in its fellowship and activities and in the ministry of the Holy Spirit throughout the body of Christ.
- k. We also believe under dispensation of the Grace of God that the apostle Paul came to us Gentiles with the Good News of the Grace of God. Acts 20:24.
- l. We also believe in his death and resurrection life for our spirit, soul and body that is the Grace of God.
- m. We also believe that the apostle Paul was sent to all to preach the Gospel of the Grace of God. Romans 1:1-12.
- n. We also believe under the dispensation of the Grace of God in Romans, chapter 8.
- o. We also believe in this de of the Grace of God in I Corinthians 12:12 for as the body is one, and hath many members, and all the members of that one body being many, are one body. So also is Christ verse 13. For by one Spirit are we all baptized into one body, whether we be Jews or Gentiles, whether we be bond or free, and have been all made to drink into one Spirit. Verse 14, for the body is not one member, but many members.
- p. We also believe under the dispensation of the Grace of God our Heavenly Father. I Corinthians 15:1-3 for I delivered unto you first of all that which I also received how that Christ died for our sins according to the scriptures. Verse 4, and that he was buried and that he rose again the third day according to the Scriptures verse 10-11.
- q. We also believe under this dispensation of the Grace of God in II Corinthians 5:10, for we must all appear before the judgment seat of Christ, that every one may receive the things done in his body, according to that he hath done, whether it be good or bad.

- r. We also believe under this dispensation of the Grace of God in II Corinthians 5:17, therefore if any man, woman, boy or girl be in Christ finished work, he or she is a new creature; old things are passed away; behold look all things are become new by the Holy Spirit. Verse 18-21.
- s. We also believe under this dispensation of the Grace of God in grace giving II Corinthians 9:7, every man according as he purposeth in his heart the real man inside, so let him give not grudgingly, or of necessity: For God so loveth a cheerful giver of his grace.
- t. We believe under this dispensation of the Grace of God that God's Grace the Lord Jesus Christ is with our Spirit. Amen.
- u. We also believe under this dispensation of the Grace of God in Ephesians 2:8 for by Grace are we saved through faith alone in his finished work of the cross and that not of ourselves: it is the gift of God's Grace: verse 9, not of works, lest any man, woman, boy or girl should boast verse 10-11.
- v. We also believe under this dispensation of the Grace of God in Ephesians 3:18-21. Ephesians 4:30.
- w. We also believe under this dispensation of the Grace of God in Ephesians 5:30, for we are members of his body of his flesh and of his bones, that is the Grace of God our heavenly Father.
- x. We also believe under this dispensation of the Grace of God in Philippians 4:13 and 23; I can do all things through Christ Jesus finished work which strengtheneth the spiritual man inside that is God's Grace.
