ARTICLES OF INCORPORATION

OF

CREACION DIVINA, INC.

THE UNDERSIGNED, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

CREACION DIVINA, INC.

The principal place of business and the mailing address this corporation shall be:

ARTICLE II

The period of its duration is perpetual, unless dissolved according to law.

ARTICLE III

The general purpose for which corporation is organized are exclusively religious, charitable, literary or educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, CREACION DIVINA, INC., if organized to act as a Orphanage for the sole purpose of proclaiming the Gospel of Jesus Christ in an efficient manner.

This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds and do those things necessary to proclaim the Gospel in an adequate manner.1

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal income Taxes under Section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, a director, officer of the corporation or any member of the corporation or any private individual (except that reasonable compensation may be paid for services rendered or for the corporation affecting one or more of its purposes).

The qualification for members and the manner of their admission are set forth in Bylaws of the Corporation. The manner in which directors shall be appointed or elected will be determined in the Bylaws.


