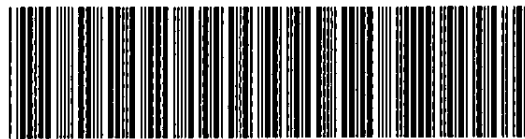

#### **ARTICLE I: NAME**
