Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

ARTICLE IX DEDICATION OF ASSETS:

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for exempt purposes of section 501(c)(3) of the Internal Revenue Code.
