- 1. We would like to amend <u>Article I</u> of Articles of Incorporation of Artefactus Cultural Project, Inc. to be read as follow:

The name of the corporation is:

Artefactus Cultural Project, Inc. (also known as Artefactus)

2. We would like to amend <u>Article III</u> of Articles of Incorporation of Artefactus Cultural Project, Inc. to be read as follow:

Artefactus Cultural Project, Inc. aims to research, production and promotion of theater, dance, music, film, visual arts, literature and other forms of non-traditional art, with emphasis on Hispanic culture. To this purpose it develops programs as Artefactus Theatre, Artefactus Gallery and Artefactus Press, among others; encourage intercultural and international exchanges; and develops workshops, meetings, conferences and festivals to promote arts education, critical and creative thinking, and multicultural values of Miami City.

Artefactus Cultural Project, Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the internal revenue code, or corresponding section of any future federal tax code. No part of the net earnings of Artefactus Cultural Project, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

3. We would like to add Article IX as follow:

Article IX

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be

distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized or operated exclusively for such purposes.
