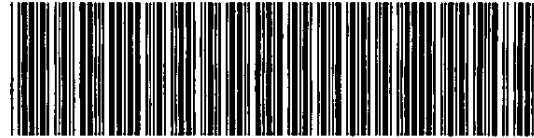

The following replaces the original article of the corresponding number.

Article XI - Distribution of Assets upon Dissolution

Upon the dissolution of the Festival of Chariots Foundation, Inc, assets shall be distributed to ISKCON of Alachua County, Inc., a church currently recognized as an organization exempt under Section 501(c)(3) of the Internal Revenue Code.

If, upon the dissolution of Festival of Chariots, Inc., ISKCON of Alachua Inc. is not recognized as exempt under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, then the organization's assets shall be distributed to an organization recognized as exempt under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
