OF
FRIENDS FIGHTING NEUROBLASTOMA, INC.,
a Florida not-for-profit corporation

ARTICLE I

Name

The name of the corporation is **FRIENDS FIGHTING NEUROBLASTOMA, INC.**, a Florida not-for-profit corporation

ARTICLE II

Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 1 day of October, 2012.

ARTICLE III

Purpose

The purpose in creating Friends Fighting Neuroblastoma, Inc., a Florida non-profit corporation is to provide children and their families facing this dreaded disease with financial assistance from the enormous amount of medical and related expenses brought on by the illness. Funds will be sought from individuals and from public and private entities via direct contact, fundraisers and other similar events. The corporation will not carry on any activities not permitted to be conducted by an organization exempt under Section 501 (c) (3) of the Internal Revenue Code and the Regulations promulgated in connection therewith.

The corporation is intending to dedicate 75% of its annual contributions to a specific patient selected by the Board of Directors, either directly to the patient or to the patient's parent, guardian or the patient's trust fund. The remaining funds will be dedicated to Neuroblastoma Research at Memorial Sloan-Kettering Hospital c/o Dr. Cheung, either directly to the Hospital or to related organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code and the Regulations promulgated in connection therewith.

Initially, most contributions will be derived from private individuals looking to provide financial assistance to families in need. Thereafter, the corporation plans to host fundraisers and other similar events in order to raise funds to provide financial assistance to stricken-patients and their families. It is also expected that the corporation will create alliances with other similar organizations to promote awareness of the disease and possibly jointly-host fundraisers to provide additional financial assistance to patients and their families and to fund research of this disease exclusively at Memorial Sloan-Kettering Hospital in care of Dr. Cheung and his staff.

Initial Board of Directors

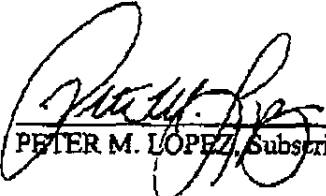
