### Restated Articles of Incorporation

## Iglesia Pentecostal Roca Inconmovible, Inc. Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

#### **Article 1 Name**

The name of this corporation shall be Iglesia Pentecostal Roca Inconmovible, Inc.

#### **Article 2 Principal Office**

#### **Article 8 Term And Dissolution**



No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the
