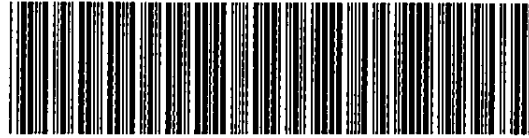

The undersigned incorporator, a natural person 18 years of age or older, for the purpose of forming a corporation under and pursuant to Chapter 617 of the Laws of the State of Florida and do hereby associate as a body corporate and adopt the following Articles of Incorporation.

Article I

The name of this Corporation shall be:

PROPHETIC LIGHT MINISTRIES, INC.

Article II

The principal place of business of the corporation shall be: 13872 SW 25TH Terrace, Miami FL 33175.

Article III

Mission Statement

We, Prophetic Light Ministries, Inc., desire to be the place where God's spirit moves freely to minister, restore, consolidate and work in the lives of God's people; seeking the heart of God in unity as one body to witness His supernatural power, signs, miracles and glory over the earth; to bring Revival to the United States of America and the world.

Prophetic Light Ministries, Inc. is a non-denominational Christian Church founded on the Word of God and the direction of the Holy Spirit. We are called to lead people, primarily born-again believers to the place where they can operate proficiently in the biblical principles of faith, love, healing, prosperity, redemption and righteousness, and to be the place where they can worship the Almighty God and share God's principles with others. We are called to build an army of believers to train them to stand firm in the spiritual warfare against darkness (Hebrews 5:12. Ephesians 6:10-18). To proclaim that "Jesus is Lord". The vision is to be accomplished worldwide through the local church and the use of television, campaigns, conventions, books, tapes,

recording, and personal correspondence and is multiplied through the financial support of other ministries and corporations like purpose. We are called to educate children, youth, and adults into Christian education from nursery, kindergarten, elementary, high school and college or university levels.

Article III

1. The purposes and objectives of this organization are:

A. to propagate the Gospel of Jesus Christ throughout the world by means of: an evangelistic ministry, revival meetings, the written Word, a mission organization, personal counseling, evangelistic meetings, training groups, church meetings, homes and group homes, ministry to train and equip believers, establishing churches, publish and/or distribute Gospel tracts and curriculum, other forms of literature, proclaim the Gospel through radio, television, internet, recorded messages of the Word, and by every adequate means throughout the world as may be determined by the Board of Directors from time to time (Mark 16:15).

B. to preach, teach, promote, disseminate, advance, demonstrate, to minister, to counsel, to save, to consolidate, to disciple, to ordain ministers, and to educate people in the ways of goodness and morality and temperance as taught in the Bible. Training and equipping believers, both internationally and domestically, toward leading closer personal lives with Jesus Christ and bringing them to maturity in our Lord so they may more effectively carry out God's will for their lives, and demonstrate the love of God.

C. to uphold and promote the Statement of Faith of the Ministry contained herein.

D. to establish and carry on the Ministry of Christian education in the knowledge and the revelation of God from the Old and New Testament.

E. 1- to solicit, receive contributions, gifts, legacies and endowments, consisting of money or other means, or acquisition of other properties from anyone; to own, hold or lease real and/or personal property and improve any thereof; to sell, convey, pledge, exchange or mortgage any part or all thereof, which will be suitable, necessary or useful for the furtherance of the objectives of the corporation and consistent with the purpose of the corporation.

2- to acquire land and hold land for the purpose of place of worship, orphanages, residences for elders or for its religious leaders, burial grounds or cemeteries, theological seminaries or similar institutions of religious

instructions (Mark 11:23-24).

F. to provide and establish benevolence, help and training programs to meet the needs of the wounded and needy (Food banks; food distribution centers to those in need).

G. to establish, maintain and conduct a Christian School for the provision of the nursery(Day Care), kindergarten, elementary, high school, and college/university facility, to provide general education for children and young people and adults in the context of Christian faith.

H. to establish own and operate one or more printing plants or publishing offices for publication, printing and distribution of Christian Literature of all types directly related to charitable objectives herein. Including but not limited to books, magazines, booklets, papers, newspapers, brochures, and any other means of printing or publishing as may become available. To produce , syndicate and distribute programs directly to the charitable objectives herein, for presentations on television, video recording, films, slides, radios, audio recordings, computer software and such other means of audio and visual presentations as many are available from time to time, and the purpose of broadcasting by mail order, hand distribution, public television, closed circuit television, AM/FM radio shortwave radio, microwave communications, computer networking, and more as they become available from time to time.

J. to facilitate a Christian bookstore, gift shop and other novelties and accepts.

K. to facilitate a cafeteria with the concession of banquets forwarding to related occasions.

L. to facilitate fitness and health center and other related programs.

M. to build a center of restoration for the abused and addicted.

N. the issuance of ministerial credentials to those qualified to preach the Gospel.

2. Except as otherwise limited herein, the Corporation shall have all powers necessary and convenient to affect or transact any or all of the business or purposes for which the Corporation is organized and shall likewise have the powers provided by the Florida Nonprofit Corporation Act.

3. The Corporation is organized exclusively for charitable, religious, educational and literary purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code of 1986 (or the corresponding

provision of any future United States Internal Revenue Law), and qualified foreign mission organizations.

4. The Corporation shall not afford pecuniary gain, incidentally or otherwise to its Directors, officers or other private persons; no part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its Directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (C)(3) of the Internal Revenue Code (of the corresponding provision of any future United States Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law).

Article IV

The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporations' Bylaws. No Director shall have any right, title, or interest in or to any property of the corporation. The manner in which the directors are elected or appointed: Directors shall be nominated by the President and approved by majority vote by existing Directors.

Article V

Godhead boldly “ Colossians 2:9, Genesis 1:26, John 14:16, Acts 5:3-4, 1 Corinthians 12: 4-6

***Human being and Son**

We were created male and female, each in the image of God, but because of our disobedience and rebellion, sin entered the world. The result is that we are now sinners by nature and practice devoid spiritual life and corrupted in every part of our being guilty and condemned and destined to permanent exclusion from the presence of God in Hell. Article VIII

Neither its Board of Directors, it's Incorporator, or its members, if any, shall be personally liable for any of the corporate obligations incurred by this Corporation. No director, officer, employee or member of the corporation shall as such, be liable on its debts or obligations and no director, officer, member or other volunteer shall be personally liable as such, for any claim based upon as act or omission of such person performed in the discharge of such persons' duties except (1) for any breach of the duty of loyalty to the Corporation, (2) for acts or omissions not in good faith or which involve intentional misconduct or knowing violation of the law, or (3) for any transactions from which such person derive an improper personal benefit. Except for any prohibition against indemnification specifically set forth in the bylaws, or in Florida Statues, at the time indemnification is sought, this Corporation shall indemnify any person who is or was a director, officer, employee, member or volunteer of this Corporation, or any such person who, while a director, officer, employee, member or volunteer of this Corporation,

is serving or has served, at the request of this Corporation, as a director, officer, partner, member, manager, trustee, employee, or agent of another corporation, partnership, limited liability company, joint venture, trust, other enterprise, or employee benefit plan to the fullest extent possible, against expenses, including attorney fees, judgments, fines, settlements and reasonable expenses, actually incurred by such person relating to his conduct as a director, officer, employee, member, or volunteer of this Corporation, or as a director, officer, partner trustee, employee, or agent of such other corporation, partnership, joint venture, trust, other enterprise, or employee benefit plan, except that the mandatory indemnification be required by this sentence shall not apply (1) to a breach of such persons duty of loyalty-to the Corporation, (2) for acts of omissions not in good faith or which involve intentional misconduct or knowing-violation of the law, or (3) for any transaction from which such person derived an improper personal benefit. The foregoing right of indemnification shall also inure to the benefit of any such indemnified person's heirs, executors, personal representatives, and administrators.

Article IX

This corporation is not authorized to issue and shall not have any capital stock.

Article X

Upon Dissolution of the Corporation, the Board shall after paying or making provision for payment of all liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (C)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board shall determine and no assets shall be transferred to or in any respect whatsoever inure to any member of this corporation or director of this corporation. Notwithstanding anything apparently or expressly to the contrary herein above contained in this Article, if any assets are then held by this Corporation in trust or upon condition of subject to any executory or special limitation and if the condition or limitation occurs by reason of the dissolution of this Corporation, such assets shall revert or be returned,

transferred or conveyed in accordance with the terms and provisions of such trust, condition or limitation.

Having been named as the registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
