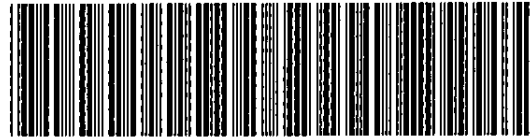

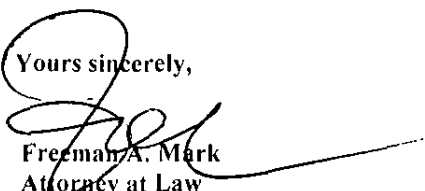

**ARTICLES OF INCORPORATION**  
**(A Corporation Not For Profit)**

**CHRIST CULTURAL CENTER, INC.**

The undersigned, for the purpose of forming a corporation not for profit under the applicable laws of the State of Florida, do(es) hereby adopt the following Articles of Incorporation:

**Article One**  
**(Name)**

The name of the corporation shall be: **CHRIST CULTURAL CENTER, INC.**

**Article Two**  
**(Principal Office & Term of Existence)**

The principal place of business and mailing address shall be at 6 Vista Gardens Trail, Unit #106, Vero Beach, Indian River County, Florida, 32962, and the duration of the corporation is perpetual.

**Article Three**  
**(Purpose & Nature Of Corporate Business)**

The purpose and nature of the business, objects and intents of the Corporation proposed to be transacted, prompted and carried on are to do any all things hereinafter mentioned, as fully and to the same extent as natural persons might or could do:

1. To engage in any not-for-profit business as related to the herein below mentioned purposes, and any other not-for-profit business, that is legal under the laws of the State of Florida, and the United States Internal Revenue Laws, Section 501(c)(3); and,
2. To promote the Bible and develop platforms online and in public through which Judeo-Christian works of art can be presented, so people can network, teach, and learn about, the culture of Christianity and express their worship to God, and to do whatever else is legal under the law.

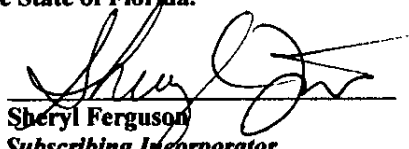

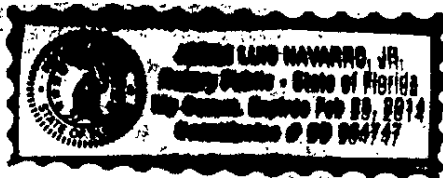

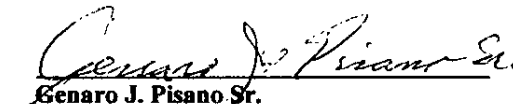
