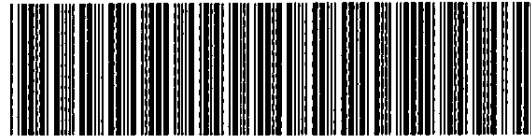

The name of this non-profit religious organization is known as "First Love Family Ministries, Inc."

Article II.

This incorporation is designated as a non-profit corporation as set forth by section 501(c)3 of the Internal Revenue Code as of this date to be known as a "charitable or religious corporation" on this date. In accordance with IRS codes at this date that distribute of its assets over liabilities upon its dissolution will be distributed to another "charitable or religious corporation".

Article III.

This Christian Conference and Church is the vision of Rev. Zenford Gause with his wife Rev. Karen Maxine Williams- Gause. The corporate address of this conference is; 2125 Fairmont Lane, Naples, Florida, 34120 USA.

Rev. Zenford Gause is known as the incorporator of this Christian Conference at the above named address. This position is for life as prescribed in our by-laws for First Love Family Ministries, Inc..

I, Rev. Zenford Gause, am the registered agent of First Love Family Ministries, Inc. My address is 2125 Fairmont Lane, Naples, Florida 34120.

Article IV.

We will set forth churches, ministries, Christian schools, camp grounds and other non-profit entities as allowed by section 501(c)3 of the IRS code on this date according to the fulfillment of the same set by-laws. We reserve the right to accept or reject applicants desiring membership with us according to our by-laws. We will do the above in the United States of America and other nations around the globe. These ministers or members will have the right to vote on future resolutions of this corporation but cannot change the original bylaws or incorporation. This right alone is governed by the founder and incorporator, Rev. Zenford Gause.

Article V.

Under *Gen. Stat. of Florida* we have the rights to the following; That any individual/organization/corporation applying or actual members waives his/her right to sue First Love Family Ministries, Inc. or its affiliates (ministers, churches, schools, organization, etc.). We reserve the right to protect and defend our corporation against those desiring to dissolve, dismantle, disempowered, overtake or to destroy credibility of this incorporation. We as First Love Family Ministries, Inc. have the right to purchase,

lease, acquire, hold, use, own, or otherwise deal in and with any real and personal property; to make contracts and incur liabilities; to elect or appoint officers; to make and alter bylaws; to lend money for corporate purposes; and to have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is organized.

Article VI.

We are a theocracy and not a democracy. As we are instructed by The King James Version of the Bible and inspiration of God's Spirit, so will we do. For further clarifications read the by-laws of "First Love Family Ministries, Inc."


