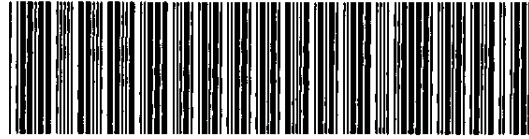

## ARTICLES OF INCORPORATION

### ARTICLE I NAME

The name of the corporation shall be: Orlando Chapter of CHUMS, Inc.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE

The purpose for which the nonprofit corporation is organized: To promote charitable, educational and religious activities in order to develop better cultural, civic and social relations among our members so that we may further stimulate our present and future generations towards the same.
