Article III (purpose)

(a) The organization is organized exclusively for charitable and educational purposes under the section 501c3 of the Internal Revenue code, or corresponding section of any future federal tax code. (b) No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to, its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes. Except as otherwise provided by section 501(h) of the Code, no substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attenting, to influence legistration. The Corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of the articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Fedral income tax under Section 501 (a) of the code as an ogranization described in section 501c3 of the code, or (b) by a corporation contribution to which are deductible under Section 170 (a) of the code as being to an organization referred to in Section 170c2 of the Code.

Article IV

Under the dissolution of the Corporation, the Board of Directors shall, after paying or making Provisions for the payment of all the liabilities for the Corporation, dispose of all the assets of the Corporation exclusively for the exempt purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for educational and charitable purposes that at the time qualify as an exempt organization or organizations under Section 501c3 of the Code, as the Board of Directors shall be distributed by the Superior Court of the division in which the corporations principal office is then located exclusively for the purposes described in section 170c2B of the Code. The use of any surplus funds for private inurement to any person in the event of a sale of the assets or dissolution of the Corporation is expressly prohibited.
