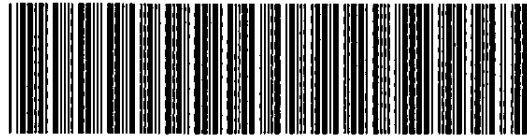

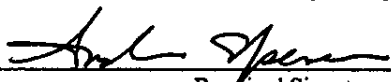

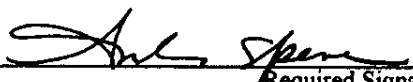

**Article VIII of the Articles of Incorporation (Not-For-Profit) Is:**

**Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, the making of distributions to organizations that qualify as exempt organizations under section 501© 3 of the Internal Revenue Code, or corresponding section of any federal tax code.**

**Upon time of dissolution of the corporation, assets shall be distributed by one or more exempt purposes within the meaning of section 501 © 3 of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose.
