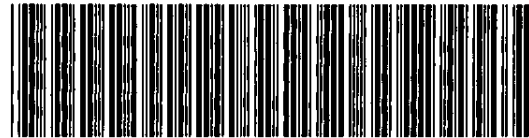

ARTICLE III : POWERS


