**ARTICLES OF INCORPORATION
OF
PEACE PROGRESSIVE MISSIONARY BAPTIST CHURCH, INC.
(A Non-Profit Organization)**

Articles of Incorporation of the undersigned individuals (Incorporators), who are 18 years of age or older, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Laws of Florida, do hereby certify :

ARTICLE I - NAME

The name of the corporation is: **PEACE PROGRESSIVE MISSIONARY BAPTIST CHURCH, INC.**

ARTICLE II - PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is located is the City of Tampa, Hillsborough County, Florida.

ARTICLE III - DURATION

The duration of the corporation's existence shall be perpetual.

ARTICLE IV - PURPOSE

The purpose of this corporation is:

- A) To spread the Gospel of Jesus Christ through programs of evangelism, education and service,
- B) To operate exclusively in any other manner for such religious, charitable, and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

ARTICLE V - BOARD OF DIRECTORS

The management of the affairs of the corporation shall be vested in a board of directors, as defined by the corporation's bylaws. The qualifications for directors and manner of their election are as regulated by the bylaws of the Corporation. No director shall have any right, title, or interest in or to any property of the corporation. 


