

Articles of Incorporation

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I – CORPORATION NAME

The name of the corporation shall be:

BAM, International Fellowship of Auburndale FL, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE AND VISION

The general purpose of this corporation is to implement its New Testament commission by these prerogatives.

(A)To administer the regular ordinances defined in the bylaws.
(B) To establish and maintain such departments, institutions, and services within the church for the purposes of the corporation.
(C) To examine candidates for the ministry and to license and ordain those who shall have been approved by the Pastor and appointed committee of their church according to the standards set forth by the New Testament.
(D) To examine candidates, appoint Missionaries, and to endorse and support Missionary programs according to the standards set forth by the New Testament.
(E) To aggressively evangelize the world and establish and maintain religious worship, to build and maintain churches, parsonages, schools, hospitals, chapels and such other religious educational and benevolent institutions as may be necessary or proper.
(F) To maintain Missionary undertaking in the United States or in any foreign country and to perform all other acts according to standards set forth by the New Testament and prescribed by and permitted under the law of the state of Florida. To accomplish the general purpose and objectives.
(G) To designate its own officers to appoint committees to arrange for its own meeting and go govern itself in accordance with the bylaws.
(H) To establish and define by which it shall be govern.

- (I) BAM International marriages, Baptism and services are in accordance with its tenets of Faith.
- (J) Homosexual & Lesbian at BAM:

Leadership position at BAM Fellowship Singing Ushers, Preachers, Teachers, Pastors, Evangelist, Elders, Missionary, Musicians of any type, any Boards, Deacon, Mothers, Financial, head of no department of any kind, Children Ministry of any type, Bus Ministry, Hospitality of any type, Greeter, Parking lot, Security, CD, or DVD, nor audio, nor T.V. nor radio ministry.

All lesbian and homosexuals are welcome to attend all services at BAM Intl. Fellowship Inc. but as long as they are actively living in that life style which goes against the holy bible: The King James Version: Romans chapter 1 verses 26, 27, 28, 29, 30, 31, 32, they may not work in leadership of any type once they have come out of this life style they can and will be put into any position of leadership that they so desire at BAM International Fellowship Inc.

SECTION 2 INTERNAL REVENUE SERVICE

- (A) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of tax future United States Internal Revenue Law.
- (B) For charitable Christian educational and scientific purpose including for such purposes, the making of distribution to organizations that qualify as exempt organizations under 501(C)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue Law.

<u>ARTICLE IV MEMBERSHIP</u>

The manner in which the directors are elected or appointed:

Members of the corporation will be required to meet the following qualifications to with to accept and agree to submit to:

- (1) The purpose of the Corporation as set out in the Articles of Incorporation.
- (2) The tenets of faith.
- (3) The requirements for membership as set out and regulated by the bylaws which may be herein and/or hereafter amended. Persons meeting such qualifications will be admitted by approval by the Board of Directors provided however, that neither members nor directors of the Corporation shall have any vested rights, interest or privileges of in or to the assets, functions affairs or franchises of this Corporation or any rights interest or privilege which may be inheritable or which shall continue after his membership ceases in the forwarded Corporation.
