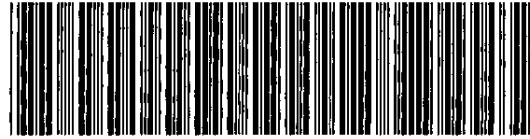

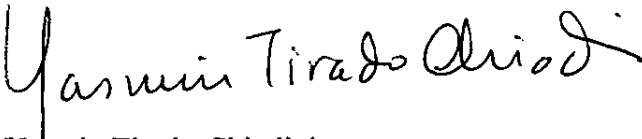

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S. (Not-for-Profit)

OF

Danny Valenson Memorial Scholarship, Inc.

ARTICLE I. NAME

The name of this not-for-profit corporation is DANNY VALENSON MEMORIAL SCHOLARSHIP, INC. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation is 4666 Eaglewood Dr., Orlando, Florida, 32817, Orange County.

ARTICLE III. PURPOSE

The Corporation organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding section of any future federal tax code. The Corporation will honor the legacy and the positive impact Danny Valenson had on his peers at University High School in Orange County, FL by providing scholarship opportunities to qualifying student athletes.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The directors of the Corporation will be elected as provided in the Bylaws of the Corporation. At the annual meeting of directors held on the 15th day in February or the following business day at the principal office of the Corporation (or as directed by the Bylaws of the Corporation), directors shall be elected by the Board of Directors in accordance with this Section. Cumulative voting by directors for the election of directors shall not be permitted. The candidates receiving the highest number of votes up to the number of directors to be elected shall be elected. Each director shall cast one vote, with voting being by ballot only.

ARTICLE V. INITIAL DIRECTORS AND OFFICERS

ARTICLE VI. INITIAL REGISTERED AGENT

The Initial Registered Agent of the Corporation is Yasmin Tirado-Chiodini, 1621 Barr St. Oviedo, FL 32765.

ARTICLE VII. INCORPORATOR

The incorporator of the Corporation is Yasmin Tirado-Chiodini, 1621 Barr St. Oviedo, FL 32765.

ARTICLE VIII. DISTRIBUTION AND 501(C)(3) LIMITATIONS

- A. This Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- B. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by (1) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- C. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

- D. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III of hereof.

On the dissolution or winding up of the Corporation, its assets remaining after payment or, or provision for payment of, all debts and liabilities of the Corporation shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
