### CERTIFICATE OF INCORPORATION OF THE ALTERNATIVE CHRISTIAN EXPERIENCE, INC.

The undersigned acting as the incorporator of a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation.

#### ARTICLE I: NAME

The name of the Corporation shall be THE ALTERNATIVE CHRISTIAN EXPERIENCE, INC., herein after referred to as "Corporation."

# ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS OF THE ARTICLE III: DURATION ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

#### ARTICLE IV: PURPOSES

The corporation is not-for-profit, and is organized and operated exclusively for religious, charitable, educational and scientific purposes under section 501 (c) (3) of the Internal Revenue Code of 1986, as amended. In carrying out the broad purposes, the corporation will by necessity and by choice, acquire real and personal property. Said property to be utilized in connection with religious, charitable, educational, and scientific activities. The incorporation will be empowered to raise funds for utilization in carrying out the above objects as allowed by the Constitution and Bylaws of the organization; to receive gifts and grants of money and property of every kind, and to administer the same for religious, charitable, educational and scientific purposes within the meaning of 501 (c)(3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, (or corresponding provisions of any future United States Internal Revenue of 1986 (or corresponding provision of any future United States Internal Revenue Law).

#### ARTICLE V: RESTRICTIONS ON ACTIVITIES

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

#### ARTICLE VI: REGISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 8012 Down Royal Road, Tampa FL 33610 and Herbert Fabio is the registered agent of the Corporation at that address.

#### ARTICLE VII: BOARD OF DIRECTORS

#### ARTICLE IX: DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
