

NAME

The name of this Corporation is ABA CANCER FOUNDATION OF FLORIDA, INC.

PURPOSE

This Corporation is a non-profit corporation and is organized pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617 of the Florida Statutes.

2.4 To do and transact all such business necessary, incidental to or in any way connected with said purposes, or any of them.


