

We, the undersigned, acting as incorporators of the Corporation pursuant chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation under the following proposed Articles of Incorporation.

### ARTICLE I:

The name of this corporation shall be DESIRE CHURCH, INC.

## ARTICLE II:

The principle place of business shall be <u>18414 NW 9th Street</u>, <u>Pembroke Pines</u>, <u>FL 33029</u>. The mailing address is <u>2902 Roellen Road</u>, <u>Murfreesboro</u>, <u>TN 37130</u>.

### ARTICLE III:

The general purposed or objective to be transacted; is to provide and maintain a church that worships God, teaches and shares the love of Jesus Christ with the community, and to live by His Spirit according to God's Word. Desire Church's mission is "Having an affectionate desire for you, we shared not only the gospel but our very lives, because you had become dear to us," (1 Thessalonians 2:8). Thus Desire Church will encourage all members to share life with those around them in order to share Jesus Christ by what we teach, demonstrate, encourage, and pursue.
