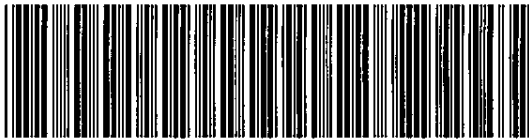

We, the undersigned, acting as incorporators of the Corporation pursuant chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation under the following proposed Articles of Incorporation.

ARTICLE I:

The name of this corporation shall be DESIRE CHURCH, INC.

ARTICLE II:

ARTICLE III:

The general purposed or objective to be transacted; is to provide and maintain a church that worships God, teaches and shares the love of Jesus Christ with the community, and to live by His Spirit according to God's Word. 
ARTICLE VIII:
