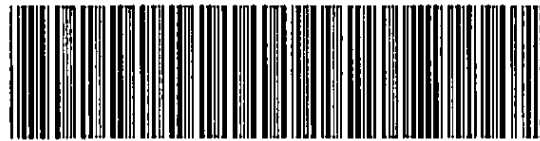

E. The Officers and Directors of the Corporation shall remain the same as follows:


