Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

- 1. The name of the Corporation as stated in the Articles filed on November 1, 2012 is WATCHING OVER YOU, INC.
- 2. The following amendment was adopted by all of the Directors on the 10th day of December, 2013 in the manner prescribed by Section 617.1006, Florida Statutes. This corporation has no members entitled to vote on the Amendment. The Amendment was adopted by the Board of Directors.
  - 3. Article III, Purpose, is hereby amended and restated in full to read as follows:

## ARTICLE - III Purpose
