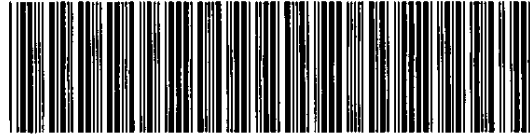


Correct the incorrect statement in Article III
