Amendment to the Articles of Incorporation of

Promise Christian Ministries, Inc.

A Florida State Non-Profit - Pursuant to section 617.1006, Florida Statutes

Article III is amended as follow:

The purposes for which the corporation has been formed are as follows:

1. PROMISE CHRISTIAN MINISTRIES, INC., is organized exclusively for charitable, religious, educational, and scientific purposes. To go into all the world and preach the gospel of Jesus Christ to all mankind. To hold meetings, seminars, trainings, and conventions, all centered in the Holy Scriptures. To prepare and ordain apostles, prophets, evangelists, pastors and teachers through a ministerial institution for the perfecting of the saints (church) for the work of the ministry, for the edifying of the body (church) of Christ till we all come into the unity of the faith and the knowledge of the Son of God unto a perfect man, unto the measure of the fullness of Christ. To provide financial support to missionaries and evangelist to accomplish the above stated tasks. To provide fellowship for Christians of all denominations. To provide a house of worship (sanctuary). To provide ministries for the spiritual development of all participants, including children. To proclaim the counsel and wisdom of God, and to enlighten mankind to the moral standards and principles in the Holy Scriptures, so that men will walk in peace with all men. To use all types of media to accomplish the above purposes. To provide training centers to prepare individuals for the development of life skills, moral character, and Godly principles that will enable them to become successful contributors to society.

Article IX - Dissolution of Corporation - is added as follows:

Upon dissolution of the corporation, the assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or

local government, for a public purpose. Any such assets not so distributed shall be disposed of by a Court of Competent

Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or

to such organization(s) as said Court shall determine, which are organized and operated exclusively for such purposes.

Article X - Earnings of the Corporation - is added as follows:

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Paragraph the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the

opposition to any candidate for public office. Furthermore, notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise any powers that are not permitted to be carried on by a corporation exempt from the federal income tax under Section 501 (c)(3) of the of the Internal Revenue code or the corresponding section of any future federal tax code or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue code or the corresponding section of any future federal tax code.
