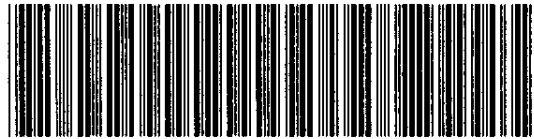

III. Purpose Statement. The Corporation, Faith Fellowship in Jesus Christ, is organized for religious, charitable, and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code including, but not limited to establishing and maintaining religious worship, churches, and schools.

IX. Private Inurement. No part of the net earnings of the ministry shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the ministry shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax exempt purposes of the ministry.

X. Political Activities. No substantial part of the activities of the ministry shall be the carrying on of propaganda or otherwise attempting to influence legislation, and that the ministry shall not participate in or intervene in (including publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

XI. Racial Nondiscrimination Clause. The ministry has a racial non-discriminatory policy and, therefore, shall not discriminate against applicants, students, employees and others on the basis of race, color, or national or ethnic origin.

XII. Dissolution Clause. Should the ministry ever be dissolved, its assets will, after paying or making provision for payment of all the liabilities of the ministry, will be transferred to a fund, foundation, or organization which is organized and operated exclusively for charitable, religious or educational purposes and shall at the time qualify as an organization exempt from federal income taxation under section 501(c)(3) as determined per the Board of Directors.

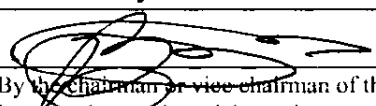
