ARTICLES OF INCORPORATION FOR

JOHN MCCARTHY MAC31 FUND, INC.

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a Corporation Not for Profit pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

<u>ARTICLE I</u> NAME

The name of the Corporation shall be JOHN MCCARTHY MAC31 FUND, INC.

ARTICLE II PRINCIPAL OFFICE

The physical address of the principal office of the Corporation shall be 2545 Dark Oak Court, Oviedo, Florida 32766. The mailing address of the principal office of the Corporation shall be 2545 Dark Oak Court, Oviedo, Florida 32766.

ARTICLE III PURPOSE AND POWERS

The primary purpose for which this Corporation is organized is to serve as a scholarship program for student athletes who display the same intensity, passion and courage that JOHN MCCARTHY exhibited during his life, his lacrosse career, and ultimately his heroic battle with Leukemia. The Corporation is organized exclusively for the following purposes: charitable, religious, educational, scientific, literary, testing for public safety, fostering national or international amateur sports competition, and/or the prevention of cruelty to children or animals, under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations, and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, to such organization or organizations which are tax exempt under section 501(c)(3) of the Code, or corresponding section of any future federal tax code, as the Board of Directors in its sole discretion shall determine.

The extent of personal liability, if any, for directors, officers, or members for corporate obligations and the methods of enforcement and collection, are as follows: NONE. Further, the Directors and Officers shall be exempt from liability and/or indemnified from costs and judgments to the full extent permitted by Florida law. In the event the Florida law is subsequently amended to authorize the further elimination or limitation of the liability of Directors or Officers of nonprofit corporations, then the liability of Directors and Officers of the limitation on person liability provided under this Article, shall be limited to the fullest extent permitted by such later amended Florida law.

ARTICLE IV MANNER OF ELECTION

Directors shall be elected as set forth in the Corporation's Bylaws.

ARTICLE V INITIAL BOARD OF DIRECTORS
