AMENDMENT Article III: Purpose of the Corporation

This non-profit corporation is organized exclusively for charitable religious, educational, and scientific purposes pursuant to the Florida Corporation's Not-For-Profit Law set forth in Section 617 of the Florida Statutes, and specifically to provide computer science and mathematics outreach, awareness, and educational enrichment among children/youth.

Including for such purposes as to receive and administer funds exclusively for scientific, literary, religious, charitable or educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code, as amended, or corresponding provisions of subsequent federal tax law. For the purposes aforesaid, this corporation shall be entitled to receive and accept gifts and bequests of money or property, whether real, personal or mixed, and to assent to carry out conditions, if any, attached to such gifts or bequests if such conditions are not incompatible with the purposes of this corporation as herein set forth; and, subject to limitations, if any, imposed by law or by instruments of transfer of any gift or bequest, to hold, invest and reinvest, grant, sell, mortgage, lease, lend, make gifts of, use and otherwise dispose of any such money or property so received by this Corporation, including the income therefrom, for any of the purposes of this Corporation as hereinabove set forth.

ADD ARTICLES Article IX: Powers and Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax

under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Article X: Dissolution

Upon dissolution of the corporation shall, after paying or making provision for the payment of all liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
