ANNEX I

TO THE ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

WOODLAND RIDGE HOMEOWNERS ASSOCIATION, INC.

Section 5.3. Annual Assessments. The association shall have the power to levy annual assessments against the Lots and the Owners thereof in the manner and for the purposes provided herein. The Association shall have the further right to require the payment of annual assessments in semi-annual installments.

ANNEX II

TO THE ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

WOODLAND RIDGE HOMEOWNERS ASSOCIATION, INC.

Section 5.4. Maximum Annual Assessment. The maximum annual assessment shall be \$480 per Lot, plus any amounts that may be assessed under Sections 5.5 or 5.6 of this Article V. Class B members shall pay 25% of the annual dues. The actual amount of the annual assessment shall be determined by the Board on an annual basis subject to the following:

- (a) The maximum annual assessment may be increased each year without a vote of the Members by an amount not more than fifteen percent (15%) over the maximum assessment for the preceding year.
- (b) The maximum annual assessment may be increased by more than the amount permitted pursuant to subparagraph (a), above, by a vote of two-thirds (2/3) of the total number of votes entitled to be cast by the Members who are voting in person or by proxy at a meeting duly called for such purpose.
- (c) The Board of Directors may fix the annual assessments in amounts which shall not exceed the forgoing limitations.
