Article III - amend to read as follows:

This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of contributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future United States Internal Revenue Law. The specific purpose for which this corporation is organized is to promote the protection and awareness of homeless, abused and abandoned animals through education of the public through electronic newsletters, social events and speaking engagements. It will also encourage financial support through charitable contributions to no-kill animal shelters and other organizations that protect homeless and abandoned animals. It will receive and administer funds for the charitable purpose enumerated above.

Article IX - ADD

Upon the winding up and dissolution of the corporation, and after, paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code.

Article X - ADD

No part of the net earnings of the corporation shall insure the benefit of, or be distributable to, any of its members, trustees, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes.

Article XI - ADD

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
