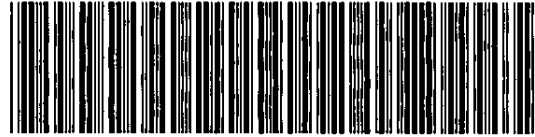

purposes and which has established its tax exempt status under Section 501 (c)(3) of the Code."


