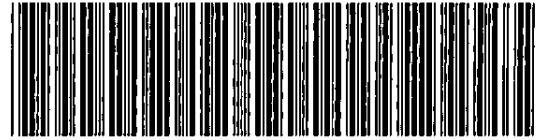

Of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, chapter 617, F. S. do hereby certify:

**Article I:** The name of the Corporation shall be Comfort Home Health Foundation, Inc.

**Article II:** Principal office of the Corporation is to be located is 3515 Palm Harbor Blvd., Ste A, Palm Harbor, FL, 34683 in Pinellas County.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."




