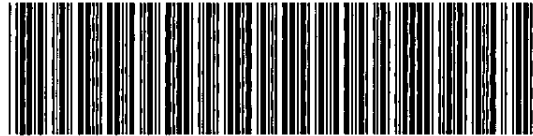

ARTICLE I - NAME

The corporation is a not-for-profit religious corporation.

ARTICLE IV - DURATION

The period of duration of the corporation is perpetual.

ARTICLE V - PURPOSE

The purpose for which the corporation is organized is:

The corporation is organized exclusively as a church for religious, charitable and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Including, for such purposes, but not limited to, the establishing and maintaining of religious worship, the evangelizing of the unsaved by the proclaiming of the gospel of the Lord Jesus Christ, the educating of believers in a manner consistent with the requirements of Holy Scripture, and the maintaining of missionary activities in the United States and in any foreign country.

ARTICLE VI - MEMBERS

The corporation shall have members. The qualifications, rights, limitations, and obligations of the members shall be set forth in the bylaws of the corporation.

ARTICLE VII - MANNER OF ELECTION

Initially, directors are appointed by President, Rick Chadwell. Hereafter, President will annually appoint directors with a confirmation and ratification from the voting membership.



ARTICLE XI - INUREMENT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Five hereof.

ARTICLE XII - PROPAGANDA / POLITICAL

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE XIII - DISSOLUTION

Upon the dissolution of the corporation, the Board of Directors shall pay or make provision for payment of all the liabilities of the corporation. Assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XIV - DISCRIMINATION

The corporation shall not discriminate on the basis of race, color, or national or ethnic origin.

ARTICLE XV - NON-ALLOWED ACTIVITIES

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
