The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be: National Sales Network, South Florida Chapter Inc. AAASP

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSES**

The specific purpose for which the corporation is organized is: The purpose for which this corporation was organized: Exclusively for charitable and educational purposes. The mission is to meet the professional and developmental needs of the African - American sales and sales management professional. Our objectives are to do this in the following five ways: To be the professional association of choice of the African - American Sales Professional. Encourage African - Americans to pursue careers in sales. Empower African - American sales professionals through community involvement and service. Provide career development strategies for African - American sales professionals. Provide a forum by which sales professionals can network among their peers. Notwithstanding any other provision of these articles, National Sales Network, An Association of African - American Sales Professionals Jacksonville Chapter, Inc. shall not carry on any activity not permitted to be carried on by: A corporation exempt from Federal Income Tax under Section 501-C-3 of the Internal Revenue Code of 1954, as amended or corresponding provisions of any subsequent Federal Income Tax laws. In the event of dissolution of the Association, all assets, real and personal, shall be distributed to such charitable organization or organizations as are qualified as tax exempt under Section 501-C-3 of the Internal Revenue Code, or corresponding provisions of any subsequent Federal Income Tax Laws.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
