

#### **ARTICLE III**

#### **PURPOSE**

#### 3.01 Purpose

WORKFORCE SOLUTIONS OF TAMPABAY INC OF TAMPABAY INC is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

WORKFORCE SOLUTIONS OF TAMPABAY INC OF TAMPABAY INC is a nonprofit agency providing employment services for individuals with disabilities that reside in the Tampa Bay area. The agency will serve as a vendor for the State of Florida to provide employment services for the Department of Education, Division of Vocational Rehabilitation program participants. The goal of WORKFORCE SOLUTIONS OF TAMPABAY INC is to foster a commitment to the consumers referred by Vocational Rehabilitation in providing employment services to the consumer for preparation into the job market. Only through adequate job training and interview skills development can the individual develop a sense of purpose that will give the individual the confidence and encouragement he/she will need to enter into and maintain a position within the workforce. By obtaining employment, this will give the individual a sense of pride and accomplishment.

Through numerous physical, emotional and mental challenges, individuals who will participate in the programs have developed low self-esteem and little hope of limitless possibilities of obtaining and maintaining employment to enhance their financial independence and self-worth.

WORKFORCE SOLUTIONS OF TAMPABAY INC will restore hope to many of the individuals who have not been successful at obtaining employment due to barriers that are often beyond their control. To accomplish this goal, individuals with disabilities must be in an environment that will address their challenges as well as accentuate their strengths. WORKFORCE SOLUTIONS OF TAMPABAY INC will provide employment training tailored specifically for preparing individuals for interviews through the enhancement of their interview and job readiness skills. WORKFORCE SOLUTIONS OF TAMPABAY INC will create a supportive, inclusive environment that promotes the best effort and reinforces positive employment outcomes.

WORKFORCE SOLUTIONS OF TAMPABAY INC will provide several programs that is in direct response to the increase of unemployed individuals and individuals with disabilities that are either transitioning from school to the workforce, have not worked in a number of years due to unforeseen health issues, were injured on the job, are re-entering the work force, discharged from the military, just being released from prison and are re-entering into society. Whatever the circumstances, the goal of WORKFORCE SOLUTIONS OF TAMPABAY INC is to increase each individual's skills, knowledge and abilities to maximize opportunities for employment through job coaching and interview skill building.

WORKFORCE SOLUTIONS OF TAMPABAY INC will focus on people with disabilities that need assistance in developing skills to obtain employment. The number of people with disabilities is steadily on the rise. With the expectancy of a continuous increase in this demographic group, WORKFORCE SOLUTIONS OF TAMPABAY INC is creating a plan that will assist these individuals with attaining gainful employment

through the establishment of partnerships with employers within the community willing to provide these individuals with an opportunity.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the Board of Directors, we may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs in order to facilitate a significant impact for change.

#### 4.03 Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The organization to receive the assets of WORKFORCE SOLUTIONS OF TAMPABAY INC hereunder shall be selected by the discretion of a majority of the managing body of WORKFORCE SOLUTIONS OF TAMPABAY INC and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against WORKFORCE SOLUTIONS OF TAMPABAY INC by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.
