## Articles of Incorporation of Always in the Moment, Inc.

### Purpose:

Said corporation is organized exclusively for charitable, religious, educational, and scientified purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Our purpose is to develop and ultimately provide others a cost-effective, eco-friendly, and nurturing environment for animals in need of rescue. To promote awareness of animal abuse and neglect while continuing to develop better systems for rescuing and caring for animals. To teach these systems to others and create an impact in the design and development of future sanctuaries.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs in order to have a greater impact for change.

#### **Dissolution of Assets:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
