Attachment to Articles of Amendment to Articles of Incorporation of Profran Foundation, Inc

Article III

- A. This corporation is organized and operated exclusively for social welfare purposes within the meaning of IRC Section 501(c)(4). The specific purpose is to provide educational information to entrepreneurs on franchising and financial funding methods.
- B. The property of this corporation is irrevocably dedicated to social welfare purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private person.
- C. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for social welfare purposes and which has established its taxexempt status under IRC Section 501(c)(4).
