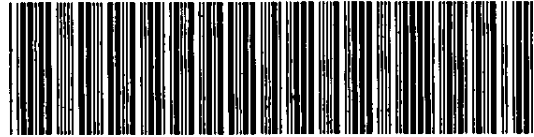

ARTICLE OF DISSOLUTION: Anderson Memorial Church of God in Christ, Inc. may be dissolved only with
authorization by its Board of Directors given at a special meeting called for that purpose and with subsequent approval by
a two-thirds (2/3) vote of the voting members.

Upon the dissolution of this organization, Anderson Memorial Church of God in Christ, Inc., all remaining assets of the
Incorporation, after payment in full of all its indebtedness, obligations, and necessary final expenses, or after the making of
adequate provisions therefore, shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3
of the Internal Revenue Code, or corresponding section of any future federal tax code, to such tax exempt organizations
(with similar purposes to those of Anderson Memorial Church of God in Christ, Inc) as shall be chosen by the existing
Board of Directors.
