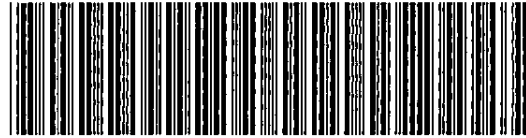



To promote the "Education," "Restoration," and "Preservation," of Historic Vehicles (Type: Military & Emergency Response) used for volunteer activities in the local community (Florida State & Monroe County, Florida)

Activities are to include but not limited to:

Disaster response, Disaster Recovery, and other emergency uses coordinated with local and state law enforcement officials.

Provide volunteer requested services for such local groups as "Wounded Warriors Project," "Make a Wish," "Toys for Tots" etc.

Offer Education and training sessions in the history, repair, and use of historic vehicles for youth groups, (High School programs, Boy Scouts and other organizations requesting such.)

Participate in Parades for US/Florida State/Monroe, Government Holiday's and other traditional local events.
