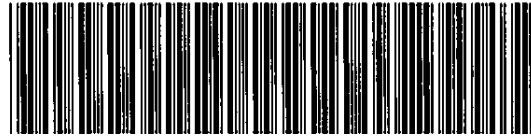

**ARTICLES OF INCORPORATION OF THE

The undersigned, pursuant to the provisions of Chapter 617, Florida Statutes, for the purpose of forming a non-profit corporation under the laws of the State of Florida, do set forth the following:

ARTICLE I

Name of Corporation

The name of the Corporation shall be "Hurtado Institute of Christian Civic Education, Inc."

ARTICLE III

Purpose

The Corporation is a non-profit corporation organized and operated exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is organized to lay a foundation of biblical Christian principles by providing educational services that promote assimilation and the development of the immigrant into their civic life in the United States of America.

ARTICLE IV

Manner of Election

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

Article VI
Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII
Term of Existence

The corporation shall commence corporate existence on January 1st, 2013 and shall have perpetual existence unless it shall be dissolved according to the laws of the State of Florida.

ARTICLE VIII

Dedication of Assets

Upon the dissolution, termination, or winding up of the corporation, assets, after the payment of all costs and expenses of such dissolution shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, the remaining assets of the Corporation shall be distributed to such charitable, religious and educational organizations ruled exempt by the Internal Revenue Service under Section 501(c)(3) and Section 170(c)(2) of the Internal Revenue Code as may be selected by the last Board of Directors of the Corporation, subject to the approval of the Hurtado Institute of Christian Civic Education, Inc.'s President and such other approvals as may be required by law or rule.

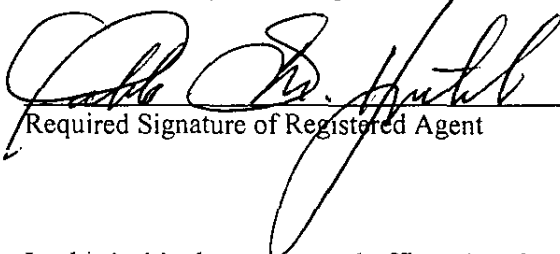

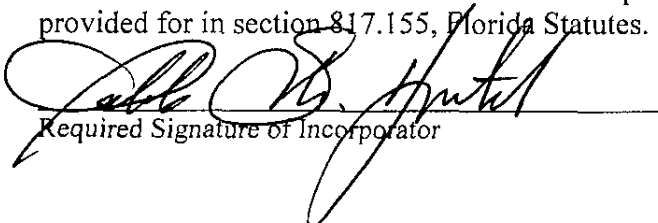
