Amendment to Article III - The corporation is organized exclusively for charitable, religious and educational purposes, under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, to provide interested readers insight into the catholic church and its ministries.

Addition of Article VIII -No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers or other private persons, except that the corporation shall be authorized and empowered to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Addition of Article IX - Upon the dissolution of the corporation, assets shall be distributed to St. Augustine Society Inc., D/B/A St. Francis House, 70 Washington Street, St. Augustine, Florida, a 501(c)(3) organization.
