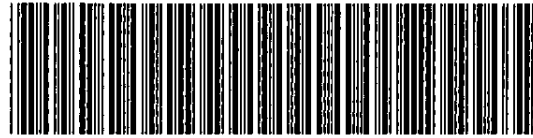

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

### ARTICLE I NAME

The name of the corporation shall be: Small Paws of Tampa ~~FLA~~, inc.

### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- (1) The corporation has been organized in perpetuity for charitable, humane and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 ( c ) (3) of the Internal Revenue Code, further said corporation has been formed to provide refuge for stray, abandoned, lost or injured animals, to place adoptable animals in permanent homes, to educate the public about animal welfare, to make funds available to pet owners and caretakers to have their pets receive veterinary care or be spayed or neutered, and to promote awareness of the mission of Small Paws of Tampa - ~~FLA~~, inc.
- (2) No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or others private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- (3) Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation,
- (4) and upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section of 501 ( c ) (3) of the Internal Revenue Code.

**ARTICLE IV - MANNER OF ELECTION** The manner in which the directors are elected and appointed

The original Directors who are the founders , including the original incorporator are designated as Directors of the Corporation , and the Chief Executive Officer (CEO) shall be elected by said group by a majority and shall serve a one year term of office or until resignation. CEO shall be elected by a majority of current directors. Each other director shall hold office perpetually or until resignation. New directors shall be elected to hold office by a majority vote of current Directors, with the number of directors not to exceed nine members.
